# 18.122Highways

### 18.124ED Streetlights

It was confirmed that A & J Lighting have been asked to install LED light units on the three street lights around Pancroft, Abridge.

# 18.125Christmas Lights

The Clerk requested quotes from five different companies with JH Contract Services and Aylesford Electrical suppling written quotations.

JH Contract quoted £4656.00 and Aylesford Electrical quoted £3200.00 for one year or £2950.00 per year on a three year contract.

After a short discussion it was AGREED with one abstention that the Aylesford Electrical three year contract would be accepted. Cllr D Hardy proposed and Cllr M Drew seconded. This was due to the cost and also because they have work with a number of other local towns / councils.

It was AGREED that a committee would be set up to deal with the Christmas Lighting joined by Cllr J Filby, Cllr D Hardy and Cllr M Drew. The committee will use the £1000 grant from the Lambridge Group to purchase any lighting or decorations that are needed. This was stipulated in a letter from Lambridge Group.

## 18.126Neighbourhood Watch

Cllr J Filby requested that a meeting be called to attempt to gain volunteers for Neighbourhood Watch. It was AGREED that a meeting would take place on 19<sup>th</sup> November at 8.00pm in the Abridge Village Hall.

## 18.127Footpath by church

The Council has documentation showing the path has a Public Right of Way going back to 1600s and is for perpetuity. Dist. Cllr B Rolfe will contact a deal with Mr C Camp regards this.
