The Clerk advised that as the wood on the Multi Play unit had been flagged as something for immediate attention and the risk rating increased, that this should be closed.

The unit will be enclosed by Harris fencing with signs saying that it is condemned. Signs will also be added to the Notice Boards and Facebook. This will be carried out on Saturday 13th May at 9.00. This will be looked at and added to the June agenda.

There are a number of other issues with the playground which need to be looked at including the fitness equipment and these will be discussed at the June meeting.

23.020 Information Exchange

Cllr H Moore mentioned that the tree at the Evangelical Church had died and asked about a donation for them to replace it.

Cllr D Moggridge mentioned that the Dog Training at the top of New Farm Drive was still going ahead and residents were being advised to contact EFDC with any complaints.

Cllr D Moggridge asked about the appeal to the footpath that goes from the top of New Farm Drive to the Church and whether it had been heard. The Clerk will investigate.

Cllr M Drewe mentioned that the rubbish bin outside the Lambourne End Parish Rooms was not being emptied regularly and was overflowing with rubbish. Cllrs Drewe and Shreeve have both been chasing EFDC over this along with other residents but it has not been emptied for at least five weeks.

Cllr M Drewe raised concerns about the work and units that are now on the field along the Ongar Road. Councillors asked the Clerk to report this to EFDC Enforcement.

Cllr D Hardy mentioned that the Council would like to move the ownership of the three pieces of equipment at the Pancroft Ring playground to EFDC control. The Clerk will speak to EFDC about this.
