22.164 Public Consultation

Four residents of Ongar Road read out a statement with regards to the parking issues they felt affected them on Ongar Road throughout the Firework Display on 5th November.

Although they fully support the Firework Display they felt that the parking was dangerous and illegal, with drives being blocked and abuse from drivers. The statement itemised this and also gave their suggestions to improve future events. The Clerk will pass this information on to the Abridge Fireworks Committee.

A resident of London Road thanked Councillors for carrying out the Survey and will attend further meetings and keep other residents updated.

Roger Gayley advertised the Big Sing that takes place on Friday 25th November. He also handed out the Church Diary for 2023 with the idea that a Community Diary could be put together.
